KINDERGARTEN CENTRAL REGISTRATION AND ENROLMENT SCHEME (CRES) POLICY

1. Purpose

The policy provides guidance for current and future parents/carers who wish to have their children enrolled in a Whitehorse PreSchool Association (WPSA) Member Kindergarten.

2. Scope

This policy applies to parents/carers who wish to apply for a kindergarten position for their children with a kindergarten participating in the WPSA Central Registration and Enrolment Scheme (CRES), and kindergarten committees or their representatives involved in the allocation of placements of children to a kindergarten program.

This policy outlines the criteria, processes and priorities used when registering a child for funded three-year-old and/or four-year-old kindergarten, with a member kindergarten, through Whitehorse PreSchool Association's Kindergarten CRES, and member kindergarten committees or their representatives involved in the allocation of placements of children to their kindergarten program.

3. Background

WPSA is a non-profit organisation formed in 1965 as Nunawading PreSchool Association. When the government amalgamated Cities of Nunawading and Box Hill, the name of the Association changed to Whitehorse PreSchool Association.

WPSA has grown from a small networking group to an information and support service for parents/carers and member kindergartens, and to a CRES.

The Victorian Government is committed to ensuring all Victorian children have access to a high-quality kindergarten program and making the process for families as simple and accessible as possible.

Central registration and enrolment provides a single point of contact for families to apply for multiple kindergarten services in their area and helps ensure children secure a place that best suits their needs. It also allows local government or non-profit CRES to establish strong links with support services, including the Maternal and Child Health Service, to identify and engage children and families who may need more support. This is why the Victorian Government is investing over \$5.5 million to support local governments to adopt, establish and enhance their own or local non-profit Central Registration and Enrolment Scheme.

4. Policy Objectives

- Provide parents/carers with a single access point for information on attending and applying for WPSA Full Member kindergarten.
- Parents/carers experience a smoother pathway to apply for and attend a WPSA Full Member kindergarten.
- Places at WPSA Full Member kindergartens are allocated in a transparent, consistent, and equitable way, and in line with the Department of Education's (DE's) Priority of Access (POA) criteria.
- WPSA Full Member kindergartens can better respond to the needs of the community, through the collection of accurate, consistent, and timely kindergarten data, to monitor and proactively manage capacity and utilisation of services.

5. Whitehorse Sessional Kindergartens

6. Eligibility

6.1 Year of attendance eligibility

To determine the year your child can commence kindergarten, and check their age eligibility, please visit DE date calculator – <https://www.vic.gov.au/give-your-child-the-best-start-in-life#when-to-start-three-year-old-kindergarten>

6.2 Three-year-old kindergarten program eligibility

The following children are eligible for funded 3-year-old kindergarten:

- children who are at least 3 years of age on or before 30 April in the year of kindergarten attendance (please note, as per Education and Care Services National Regulations 2012, a child must be 3 years of age before they can commence a program)
- children who were eligible to attend a 3-year-old kindergarten program in the previous year but delayed commencement.
- children who have a Declaration of Eligibility for an additional year of funded kindergarten (refer item 6.7).

6.3 Four-year-old kindergarten program eligibility

The following children are eligible to access funded 4-year-old kindergarten:

- children who are at least 4 years of age on or before 30 April in the year of kindergarten attendance.
- children turning 6 years of age during the kindergarten year who have been granted an exemption from school entry age requirements by their regional DE office. (refer item 6.8).
- children who are younger than the eligible age but whose parents/carers have submitted a written request to their regional DE office and have been approved for their child to attend kindergarten the following year (refer item 6.6).
- children eligible for Early Start Kindergarten (refer item 6.5).
- children who have a Declaration of Eligibility for an additional year of funded kindergarten (refer item 6.7).

6.4 Pre-Prep

From 2026, between 16 and 25 hours of pre-prep will be available statewide to:

- Aboriginal and Torres Strait Islander children
- children from a refugee or asylum seeker background
- children who have had contact with Child Protection services
- children supported by Early Start Kindergarten or Access to Early Learning in their 3 year old kindergarten year.
- The pre-prep program for children from a priority cohort group will be for 16-25 hours each week in Whitehorse.
- If you think your child meets one of the eligibility criteria for pre-prep, talk to WPSA about what the program may look like for your child.
- If your child is currently accessing Early Start Kindergarten, they are eligible for pre-prep next year.

6.5 Early Start Kindergarten

Early Start Kindergarten (ESK) is available to eligible children and provides them with 15 hours a week of free or low-cost kindergarten, in the two years before they start primary school. To be eligible for ESK a child must turn 3 on or before 30 April of the first year of kindergarten attendance, and:

- are from a refugee or asylum seeker background, or
- identify as Aboriginal or Torres Strait Islander, or
- are from a family that has had contact with child protection.

Four-year-old children who meet the above criteria can also access free or low-cost kindergarten the year before attending school through the ESK Extension Grant, regardless of whether they have accessed ESK in the previous year.

Parents/carers who think they are eligible for Early Start Kindergarten are encouraged to contact the DE Early Years team or talk with their Maternal & Child Health Nurse to confirm eligibility and for support.

6.6 Early entry to primary school

A child who is less than four years of age by 30 April in the year they are to attend a funded 4-year-old kindergarten program, may only attend the program if the child's parent(s)/carer(s) have requested and been granted approval for early entry to school.

Requests must be made in writing to the appropriate DE regional office in accordance with government school entry processes, or directly to the non-government school the child will be attending. A copy of the written approval for early school entry must accompany the registration. The kindergarten service must also sight this approval and include a copy in the child's enrolment record.

Parents/Carers must be aware that early entry into kindergarten does not guarantee early entry into school, and if their child does not proceed to primary school the following year as planned, they will be unable to access another year of funded kindergarten, unless approved by DE (refer item 6.7).

6.7 Additional year of funded kindergarten

A child is eligible to receive one year of additional funding for kindergarten if:

- a) The child is observed as having delays in at least two outcome areas of learning and development detailed in the Victorian Early Years Learning and Development Framework, and
- b) There is evidence to suggest the child will achieve better outcomes if the child attends a second year of 3 or 4-year-old kindergarten to strengthen the learning and development of skills in these areas which will better facilitate transition to school the following year.

The Early Childhood Teacher is responsible for determining a child's eligibility to receive a second year of funded kindergarten.

If the child is turning 6 years of age in their second year of kindergarten an exemption from attending primary school must be sought from DE by the parents.

WPSA must be notified by the kindergarten of the number of estimated second year places before the end of June in the year prior to the second year of attendance.

Additional year of funding notifications must be advised to WPSA from the kindergarten and not the parents/carers to ensure it is teacher recommended and supported.

If you are wanting your child to have their additional year of funding at a different kindergarten, you must have a Declaration of Eligibility for an additional year of funded kindergarten to provide to the new kindergarten.

A child is eligible for one year only of additional funding.

6.8 Exemption from Primary School

Children who are turning 6 years of age* (the compulsory school age in Victoria) during the first or second year of funded 4-year-old kindergarten must be approved for kindergarten funding and exempted from attending school by the Department of Education (DE).

It is the parents/carers responsibility to ensure an “Exemption from school due to attendance in a funded kindergarten program” form is submitted to the relevant DE regional office by 1 November in the year prior to the child turning 6.

*The exception to this is children who will turn 6 in late December (between the last day of the school year and 31 December). They can attend 4-year-old kindergarten in that year and attend school the following year.

6.9 Immunisation Status

‘No Jab, No Play’

The Victorian Government has amended the Public Health & Wellbeing Act 2008, effective January 2016. The amendments mean that early childhood education and care services cannot confirm enrolment of a child unless the parent/carer has provided the Australian Immunisation Register (AIR) History Statement that shows the child:

- is fully vaccinated,
- is on a recognised catch-up schedule if their child has fallen behind with their vaccinations, or
- has a medical reason not to be vaccinated.

Parents/Carers are required to obtain an Immunisation History Statement for their child from the Australian Immunisation Register (AIR). You can access the child's immunisation history statement using either the Medicare online account through myGov or via the Medicare mobile app. Alternatively, you can:

- ask your vaccination provider to print a copy for you from the AIR site
- call the AIR on 1800 653 809 (8am-5pm, Monday to Friday) and request a copy to be mailed to you (this can take up to 10 business days)
- request a copy at a Services Australia Service Centre.

In some circumstances, a 16 week ‘grace/support period’ can be applied so a child can start at the service while a statement is obtained. Children whose parents/carers have not provided evidence of their immunisation status or have provided evidence that states they are not up to date with their immunisations are eligible for the support period if they:

- identify as Aboriginal or Torres Strait Islander
- are a refugee or asylum seeker
- are from multiple births of triplets or more
- hold or their parent/carer holds a healthcare card
- have a parent/carer who is a pension concession card holder
- are evacuated from their home due to an emergency (such as a flood or bushfire)
- are in the care of an adult who is not their parent due to exceptional circumstances (such as parental illness or incapacity)
- are in the care of a parent who is a **Gold or White Department of Veterans' Affairs** card holder
- are involved with child protection services, or have been in the past
- receive support through Family Services, or have in the past
- are living in crisis or emergency accommodation
- are being supported by a housing agency or family violence service

7. Application Process

7.1 Lodging an Application

- Applications are lodged through our website's www.wpsa.com.au online applications. Applications can be lodged for 3yo, or 4yo, or both 3yo&4yo combined.
- Applications can be lodged from a child's second birthday.
- Applications must be accompanied with an accepted proof of residential address document or an explanation why an accepted document cannot be provided.
- Applications must include the child's up-to-date Australian Immunisation Register (AIR) History Statement. This document will also provide proof of a child's date of birth.
- A copy of a Commonwealth concession card held by the family or child must be provided with the application showing names and expiry date. It is the responsibility of the parents/carers to keep WPSA advised of up-to-date card and expiry date.
- Applications must include at least one kindergarten choice and can include up to three.
- As of 9 February 2024 an application fee is no longer required thanks to CRES funding through the [Central Enrolment Project](#).
- Applications should be lodged by 30 June the year prior to that being applied for. Applications received after this date each year may be placed on a late waitlist. This includes any changes to existing applications.

- Support is available through WPSA to complete the application process if needed.
- Applications will receive an automatic bounce back email and will be followed up with a formal acknowledgment from WPSA by email once they are checked as complete.
- Changes to existing applications are made by email to WPSA.
- Additional year of funding notifications must be made to WPSA by the kindergarten or educator, so it is known to be teacher recommended and supported. A new application is not needed for the additional year of funding when the child is already applied with WPSA.

7.2 Offer and Allocation Process

- Applications received by 30 June with all correct supporting documents will be part of first round offers.
- Offers will commence late July for next year's places.
- Places will be allocated as per each kindergarten's eligibility and priority of access criteria.
- WPSA Eligibility and Priority of Access Criteria, see Appendix 1.
- Offers will be emailed to the preferred email address registered on the application.
- The offer will need to be responded to by the date stipulated in the offer email otherwise it may be rescinded and offered to the next person on the waitlist.
- An acceptance deposit may be required to be paid to confirm a position. This deposit will be offered as a refund once a child commences in the kindergarten program.
- Vacancies created from declined offers will be offered in order of sorted applications, as per the application of the eligibility and priority of access criteria.
- First round offers will continue until a kindergarten's request list is exhausted or all positions have been offered and accepted.
- Second round offers will commence mid-August and will be when second and third choices are considered.
- Late applications and late changes received after 30 June will be considered for a position mid-late August.

WPSA Eligibility and Priority of Access criteria for 3- and 4-year-old kindergarten

- *Three- year-old kindergarten is a government funded program, 5-15 hours per week of free kindergarten.*
- *Four-year-old kindergarten is a government funded program, 15 hours per week of free kindergarten.*
- *Pre-Prep is a government funded program making 4-year-old kindergarten available free for between 16 to 25 hours per week for children: who identify as Aboriginal or Torres Strait Islander; from a refugee or asylum seeker background; or who have had contact with Child Protection services.*

ELIGIBILITY

- All children must meet ‘No Jab, No Play’ Legislation requirements.
- Pre-Prep, Four-year-old (4yo) or mixed age - a child must have turned 4 years of age by April 30 in the year they are to attend to coincide with school entry.
- Children who turn 6 during their 4yo kindergarten/pre-prep year and have received approval for an exemption to attend school from the Department of Education (DE).
- Children younger than the 4yo kindergarten eligible age who have a written request and response from the Department of Education (DE) seeking an early entry to school. (Note: very few early school entry requests are approved by DE and if the child attends kindergarten early, but does not proceed onto school the following year, it is not possible to access another year of funded 4yo kindergarten).
- Three-year-old (3yo) or mixed age - A child must have turned 3 years of age by April 30 in the year they are to attend to coincide with school entry.
- Three-year-old (3yo) or mixed age - A child must be 3 years of age before they can commence the program as per Education and Care Services National Regulations 2012.

SELECTION PROCESS

If more eligible children apply for a kindergarten place than there are available places, applications will be prioritised in line with the Department of Education’s Priority of Access Criteria below.

After applying the Priority of Access criteria above and where relevant, the Pre-Prep criteria, and there are still places available, the following will be applied to determine the order of enrolment offers.

1. LOCAL FACTORS – considered in conjunction with each other.

• **PROXIMITY**

- For this clause, the residential address will be used, appropriate proof of address must be supplied. As the crow flies is used to calculate distance.

• **RELATIONSHIP TO KINDERGARTEN**

- SIBLINGS - Siblings of previous or current attendees at the first preference kindergarten;
OR, where the first preference kindergarten is part of a primary school, current attendees at the school and/or kindergarten.

2 OTHER REPEATING

- Children who have attended a funded kindergarten program and are eligible for a second year of funded kindergarten as recommended by an Early Childhood Teacher and have a Declaration of Eligibility and request the second funded year of kindergarten to be at another kindergarten.

3 SPECIAL CIRCUMSTANCES - *may be considered in conjunction with above criteria*

Any special circumstances, which the Committee and Early Childhood Teacher agree is appropriate to consider. For example:

- Additional Needs – an applicant who has additional needs or a family member of the applicant who has additional needs not considered under Priority of Access.

If there are more applicants than positions available, and applicants are on equal standing after the above criteria has been applied, offers will be determined by ballot.
